#### **BACKGROUND**

At the meeting of the #SaferLeonora Committee held 9<sup>th</sup> August, 2022 Sgt Jamie Cresswell proposed the construction of a "Rage Cage" to support Focus 1 of the #SaferLeonora Plan 2022-2027 – 1.1.2 – Encourage activity in local parks, spaces and facilities.

A "Rage Cage" is an all-in-one permanent outdoor sport and recreation complex, designed to incorporate over ten of the most popular Australian and International sports. The cage allows young people to play multiple sports without the need to set up or be supervised. Further, the Rage Cage is a hardy, durable installation designed to incur minimal damage and also keep balls and equipment off the road, improving safety of road users and community members alike.

It was decided that if permission to use the lot where the old Department for Child Protection and Family Services is located could be obtained, this would be an idea area to install the rage cage.

Since this meeting, Sgt Cresswell has obtained a pricing list for a Rage Cage installation and has advised that if the location already has a concrete base, the cost of installation will be reduced.

Contact has been made with Erin Bond, Regional Manager, Goldfields from the Department of Local Government, Sport and Cultural Industries (DLGSCI). The Community Sporting and Recreation Facilities Fund (CSRFF) Small Grant round will be opened on 1st February, 2023 for projects up to the value of \$300,000 (excluding GST). It is in the best interest of the Committee to keep the cost of the project below \$300k. This project suits the criteria of the grant because there are a lack of recognised

sporting opportunities in Leonora, this becomes an opportunity to introduce a chance for people to be involved in sport.

The CSRFF grant can contribute up to one third towards the costs of the project.

Lotterywest have also expressed an interest in supporting projects such as this one where other funding partners have been included. The Committee can therefore approach Lotterywest for an additional third of the project. The remaining third will need to be raised.

It is recommended that the Committee approach local mine operations and the Shire of Leonora to raise the final funds required.

The Shire of Yalgoo has recently received funding from DLGSCI through their CSRFF small grant round to install a Rage Cage. A request was made to the Shire of Yalgoo to share their grant application with the #SaferLeonora Committee to simplify the grant application process. Erin Bond will provide a copy of the previous grant application form so that the grant can be developed prior to the opening of the CSRFF round in February and be developed into a shovel ready project.

With regards to the Land Parcel, the #SaferLeonora Committee require a letter from the Department of Communities indicating that there is approval to construct on that space.

A request has been made to obtain this approval and we are currently waiting for a response.

#### STRATEGIC IMPLICATIONS

There are costs involved with the installation of the Rage Cage as noted, and additional funding outside of the abovementioned grant opportunities will need to be raised. Total Project Cost estimated to be no greater than \$300,000 excluding GST.

#### **BACKGROUND**

Michelle Blackhurst, WALGA RoadWise Regional Road Safety Advisor has advised that two grants are opening in January, 2023 regarding Road Safety.

The Road Safety Community Grant Program provides funding from the Road Trauma Trust Account to support the development and implementation of projects and community activities that relate to road safety.

There are two grants available. Community Event Grants provide up to \$5,000 to support road safety promotions. These grants aim to inform the community and help save lives on Western Australian roads. Community Project Grants provide up to \$25,000 to support road safety projects. These grants aim to address road safety issues.

It is recommended that the Committee investigate possible projects that can take advantage of one or both of these grant opportunities to further advance Focus Area 4 of the #SaferLeonora Delivery Plan: Community Action, Connection and Involvement, particularly in regard to Community Safety.
